## 1. PURPOSE

To state the requirements to be met by **Affiliated Colleges** of the Australian University of Theology (AUT) in representing the **University** and its **courses** to students and in providing information to students about studying in AUT courses.

## 2. DEFINITIONS

Definitions for any words in **Bold** in this document can be found in the [Policy Glossary](#). The first instance of each defined term has been outlined in bold.

## 3. SCOPE

These rules apply to all printed and online material either disseminated to students or made publicly available by Affiliated Colleges of the University.

## 4. RULES

### Representing the relationship to the University

- 4.1 The stated relationship between the Affiliated College and the University must not be misleading and must clearly identify AUT as the registered **Higher Education Provider (HEP)** associated with accredited AUT courses.
- 4.2 The following wording must be included in the websites of Affiliated Colleges:

Website footer (or another consistent place on all webpages): “[College name] is an Affiliated College of the Australian University of Theology, CRICOS: 02650E”<sup>\*1</sup> – with the words “Australian University of Theology” linked to <https://www.aut.edu.au>. AUT’s logo may be included but is not required.

- 4.3 If an Affiliated College refers to the University in its email signatures or letterhead, the wording quoted for websites in 4.2 must be used or else as a minimum, “Australian University of Theology, CRICOS: 02650E.”<sup>\*</sup> The AUT initials are only to be used with the **CRICOS** code (e.g. “AUT CRICOS: 02650E”) if the AUT’s name in full appears in close association, e.g.

“[College name] is an Affiliated College of the Australian University of Theology.

[College initials] ABN xx xxx xxx xxx | AUT CRICOS: 02650E.”<sup>\*</sup>

### Representing AUT courses

- 4.4 Where an Affiliated College provides an overview of available courses, the following wording may be used or alternative wording conveying the below message may be used:

“As an Affiliated College of the Australian University of Theology, [college name] is approved to deliver the following courses of the AUT (CRICOS 02650E).”<sup>\*2</sup>

For online content, the words “Australian University of Theology” must be linked to <https://www.aut.edu.au>. AUT’s logo may be presented adjacent to the wording above.

- 4.5 Descriptions of individual AUT courses may include the below statement or alternative wording can be utilized to ensure that the provider and the accrediting body of the courses are explicitly indicated:

“This is a course of the Australian University of Theology.”<sup>\*3</sup>

For online content, the words “Australian University of Theology” must be linked to <https://www.aut.edu.au>. AUT’s logo may be presented adjacent to the wording above.

- 4.6 The names of AUT courses must exactly correspond to those on the AUT “Our courses” webpage (<https://www.aut.edu.au/our-courses/>) without any addition including wording in parentheses.
- 4.7 Descriptions of AUT courses must be aligned with the rationale and course **learning outcomes** stated for the courses on the AUT “Our courses” webpage (<https://www.aut.edu.au/our-courses/>). If course learning outcomes are included in course descriptions these must exactly correspond with those on the AUT’s webpage. See the section of these rules entitled *Representing admission requirements* for rules about representing course admission requirements.
- 4.8 Affiliated Colleges may only represent AUT courses they have the approval to offer.

\* Affiliated Colleges with *no* approved CRICOS sites must not display the CRICOS reference, i.e. “CRICOS: 02650E”.

- 4.9 If Affiliated Colleges choose to advertise the availability of the **delivery mode** of a course, colleges may only advertise the availability of **delivery modes** of a course that the college has been approved for.
- 4.10 Where an Affiliated College offers AUT's Academic Studies in Theology Certificate or Certificate in Theology, it is stated that the courses are not an Australian Qualifications Framework (AQF) qualification.
- 4.11 Where an Affiliated College is accredited to offer its own courses, it is clearly stated which courses are offered under the accreditation of the Affiliated College and which through the AUT.
- 4.12 Where an Affiliated College is accredited to offer its own courses, or offers non-accredited programs, it must be made clear to students in AUT courses the policies and other content that is relevant to them. For example, a "Policies" webpage should clearly demarcate the policies for AUT students from those for other students of the Affiliated College.
- 4.13 To avoid any confusion about the accreditation status of a program of study, internal programs of an Affiliated College (for example, a set of units required for ordination) should be referred to wherever possible as a "program", rather than a "course". The representation of such programs must make it clear that they are not offered through the AUT.
- 4.14 Where AUT **units** are represented as available for study as **Single Unit Study** and as eligible for gaining credit towards a course, the [Coursework Course Enrolment Policy](#) must be referenced.
- 4.15 Representations, whether expressed or implied, about the outcomes associated with undertaking an AUT course must not be false or misleading, including in relation to possible employment outcomes, professional accreditation, or migration outcomes.

### Representing courses to overseas students

Where an Affiliated College is approved to offer AUT courses to **overseas students**, the following additional rules apply. To avoid any uncertainty, this refers only to students who hold a student visa, enrolled with the University through its Affiliated Colleges. It does not include students studying online from an overseas location.

- 4.16 Any printed or online material that is disseminated or publicly available and directed towards overseas students must include the AUT's name in full ("Australian University of Theology") and its CRICOS provider code (02650E).
- 4.17 Where it is represented that a course is available to overseas students, the CRICOS course code must be included.
- 4.18 Any printed or online material about AUT courses for overseas students must include:  
"[College name] is approved to deliver the following courses of the Australian University of Theology (CRICOS 02650E) to overseas students."<sup>4</sup>

For online content, the words "Australian University of Theology" must be linked to <https://www.aut.edu.au>, and "02650E" linked to either <https://cricos.education.gov.au/Institution/InstitutionDetails.aspx?ProviderCode=02650E>, or the specific CRICOS link for the delivery location from this webpage.

- 4.19 Affiliated Colleges must only represent courses as available to overseas students which have CRICOS approval for delivery at its site(s). These courses are to be confirmed by the college on the CRICOS website (<https://cricos.education.gov.au/Institution/InstitutionDetails.aspx?ProviderCode=02650E>).
- 4.20 Affiliated Colleges must provide information to assist overseas students in their planning for study. This information must include indicative costs of living and studying in Australia, accommodation options, arrangements for health care and, where applicable, schooling obligations related to school-aged dependents (including the possibility that school fees may be incurred). This information may be provided through a link to AUT's "Overseas Students" webpage ([aut.edu.au/overseas-students](https://www.aut.edu.au/overseas-students)) with a statement that such information is available at the website. Alternatively, Affiliated Colleges may develop their own content covering listed areas and with at least an equivalent level of detail to that on the AUT webpage.
- 4.21 Advice to overseas students in relation to studying AUT courses is only provided by the Affiliated College's Overseas Students Liaison Officer, who must be identified to, and receive training from, the AUT Office.
- 4.22 Affiliated colleges must indicate on their Overseas Courses page that onshore overseas students are not eligible to enrol in AUT's fully online courses.
- 4.23 AUT staff will ensure that the [Overseas Student Transfer and Release Policy](#) is available and can be accessed by overseas students and affiliated college staff.
- 4.24 Affiliated colleges must avoid any form of direct promotion of AUT courses that could entice students enrolled with other providers and must not make any representations or offers that may improperly influence a student to transfer, in accordance with the requirements of National Code: Standard 7.
- 4.25 Colleges must not promote AUT courses that are exclusively online to overseas students (holders of a student visa – see definition on page 3).
- 4.26 Colleges must provide information on the affiliated college website and/or in other handouts on how students can seek assistance and report an incident that significantly affects their wellbeing.

### Representing admission requirements

- 4.27 Where an Affiliated College provides descriptions of AUT courses, these must include the admission requirements found on the AUT "Our courses" webpage ([aut.edu.au/our-courses](https://www.aut.edu.au/our-courses)). This includes English language proficiency requirements.
- 4.28 Information advising students about the application process or admission requirements for an AUT coursework course will refer students to the AUT [Coursework Course Enrolment Policy](#).

- 4.29 It is a requirement of the [Coursework Course Enrolment Policy](#) (section 5.6) that admission requirements set by Affiliated Colleges, including those related to a statement of beliefs or a code of conduct, be available in writing and communicated to students prior to admission. The means of this communication must be reported to the AUT using the *Admission requirements Tickit* form.
- 4.30 Where the application process for an AUT course involves the provision of information about personal beliefs and religious experience, such as an account of faith and church participation, any associated admission requirements must be clearly stated.

### **Provision of information related to student experience**

- 4.31 Affiliated Colleges must provide information to assist students in making decisions about AUT courses. This information must be available before students accept an offer and must be either duplicated from AUT content and maintained or provided through links to the relevant AUT documents or webpages, or by embedding the live AUT website information onto the college website. Access to the following information for each course is required:
- 4.31.1 course rationale;
  - 4.31.2 course structure;
  - 4.31.3 course rules;
  - 4.31.4 admission requirements; and
  - 4.31.5 course learning outcomes.
- 4.32 For content and materials about fees for AUT units or courses, the following statement may be included:
- “[College name] is an Affiliated College of the Australian University of Theology (AUT). The tuition fees are set by AUT on an annual basis. More information about tuition fees is available at <https://www.aut.edu.au/tuition-fees>.”<sup>5</sup>
- Alternate wording can be used to convey the above message.
- 4.33 Students must be given reasonable notice of changes to fees or other costs associated with courses. This will generally involve giving more than three months’ notice before the commencement of a semester.
- 4.34 Affiliated Colleges are to refer to the [Information on Student Support Services Rules](#) for requirements about providing information on student support services prior to admission.

### **Representations and LOTE delivery**

Where an Affiliated College is approved to offer AUT courses in a Language Other Than English (LOTE), the following additional rules apply.

- 4.35 Affiliated Colleges that are approved to deliver and represent AUT courses in a LOTE must use the AUT's translations for descriptions of the relationship to the AUT and the AUT course names. These translations are available in Appendix 1.
- 4.36 Where a course is offered in a LOTE, the language must be specified in all representations of the course including those on the Affiliated College website and in any printed or electronic materials distributed to students.

#### List of AUT policies that must be provided by the Affiliated colleges to students

- 4.37 Affiliated colleges must provide access to at least the specified policies relevant to students prior to admission to a coursework award. A list of the minimum mandatory policy list can be found in Appendix 3. Affiliated Colleges can choose from the below options on how to represent AUT policies to students:
- In full text, embedded in documents such as a college student handbook;
  - Policy titles linked to individual permalinks to AUT policy documents;
  - Policy titles only and a single link to AUT's all policies page;
  - Another form of written communication to students which achieves this outcome.

Affiliated Colleges will inform AUT of the communication method of relevant AUT policies from Appendix 3 to students via a Tickit form on request.

#### Use of the AUT logo

- 4.38 Affiliated Colleges are to use the AUT's logo either in colour or monochrome (Appendix 2 shows the variants of AUT's logo).
- 4.39 Where the logo does not appear directly next to prominent placing of the words "Australian University of Theology," colleges are to use the version of the logo which includes the text "Australian University of Theology."
- 4.40 Where the logo appears directly next to prominent placing of the words "Australian University of Theology," colleges can choose to use the version of the logo with the text "Australian University of Theology" or the version of the logo without the text.
- 4.41 The AUT office can provide various formats of the AUT logo (with or without text). Affiliated Colleges must only use a version of the logo provided by the AUT office.
- 4.42 AUT's name and logo may only be used by partners of an Affiliated College with the written permission of the **Vice-Chancellor**.<sup>6</sup>

### 5. QUALITY ASSURANCE

- 5.1 The AUT Office will conduct audits and monitor Affiliated College representations on an annual basis to check compliance with the rules of this document. Affiliated College compliance with changes to this document will be assessed in the following

annual review of affiliated colleges or otherwise implemented as directed by the AUT Vice-Chancellor.

Instances of non-compliance with the rules of this document will be reported immediately to the **Chief Operating Officer** and also noted in the report to the Finance, Risk, Audit & Compliance Committee on Affiliated College compliance with the Affiliation Agreement. The **Quality Manager** will monitor action required by Affiliated Colleges to address identified noncompliance and report outcomes to the Chief Operating Officer.



