## 1. PURPOSE

To ensure the **University's** research culture is based on the principles espoused in the Australian Code for the Responsible Conduct of Research (**Code for Research**) and the National Statement on Ethical Conduct in Human Research (**Statement on Ethical Conduct**).

## 2. DEFINITIONS

Definitions for any words in **Bold** in this document can be found in the Policy Glossary. The first instance of each defined term has been outlined in bold.

## 3. SCOPE

This policy applies to all **AUT affiliated researchers** and **HDR candidates**, as well as students conducting **human participant research**.

### 4. POLICY STATEMENT

The **University** is committed to **research** which is conducted responsibly, ethically and with integrity, built on the principles articulated in the **Code for Research** and **Statement on Ethical Conduct** summarised below:

### Code for Research

- Honesty
- Rigour
- Transparency
- Fairness
- Respect
- Recognition of the rights of Aboriginal and Torres Strait Islander peoples
- Accountability
- Promotion of responsible research practices

### Statement on Ethical Conduct

- Research merit and integrity
- Justice
- Beneficence
- Respect

All researchers affiliated with the University must familiarise themselves with the Code for Research as well as the Statement on Ethical Conduct, if they are conducting human participant research.

**Researchers** who breach the **Code for Research** or the **Statement on Ethical Conduct** will be dealt with in accordance with the *Research Misconduct Procedure*. Academic misconduct arising during coursework, including coursework associated with **HDR candidature**, will be dealt with under the *Academic Integrity Policy for Coursework Awards*.

# 5. PRINCIPLES

# **General Principles**

- 5.1.1 The primary responsibility for ensuring the integrity of research lies with individual **researchers** and institutions.
- 5.1.2 In line with the principles of the **Code for Research**, where permitted, the use of artificial intelligence tools (including, but not limited to, ChatGPT or similar) must be acknowledged.
- 5.1.3 HDR Candidates must have written authorisation from their principal supervisor in order to utilise artificial intelligence tools (including, but not limited to, ChatGPT or similar) for text generation, and appropriately reference as outlined above.

## AUT's responsibilities

- 5.2.1 Through its research culture, the **University** will foster responsible research conduct, encouraging and supporting it.
- 5.2.2 The **University** will do this in accordance with the responsibilities of institutions outlined in the **Code for Research**.
- 5.2.3 The University will ensure that researchers have access to the Code for Research and the related Guides, as well as the Statement on Ethical Conduct, where required.
- 5.2.4 Human participant research will be reviewed under the auspices of the HREC in accordance with the HREC Terms of Reference, the Low Risk Ethics Committee and Approval Rules, the Ethics Protocol and associated documents.
- 5.2.5 Research Coordinators (Postgraduate Coordinators) from each Affiliated College act as Research Integrity Advisors (RIAs). RIAs will be trained through the Research Integrity Office and provided with a copy of the Research Integrity Advisor Guide.
- 5.2.6 **Supervisors** will be trained through the **Graduate School of Research** and provided with a copy of the Guide on Supervision.
- 5.2.7 The requirements of the **Code for Research** will be included in induction training for **HDR candidates** through the **Graduate School of Research**.

## Researcher's responsibilities

- 5.3.1 **Researchers** will uphold the principles of responsible research conduct in all aspects of their **research**, in accordance with the responsibilities of researchers outlined in the **Code for Research**.
- 5.3.2 If **researchers** need guidance on a particular matter, they should contact a **Research Coordinator** (**RIA**), either at their own college or at another **Affiliated College**, if they

prefer. **Researchers** who are **HDR Candidates** or **coursework students** may also discuss the matter with their **supervisor** or **project coordinator**.

## Supervisor's responsibilities

5.4.1 **Supervisors** of **HDR candidates** have particular responsibilities and must act in accordance with the Guide on Supervision.

## Breaches of the Code and Research Misconduct

5.5.1 All allegations of breaches of the **Code for Research** will be dealt with by the **Research Integrity Office** in accordance with the *Research Misconduct Procedure*.

## 6. QUALITY ASSURANCE

A marker of the effectiveness of this policy will be the extent to which **researchers** comply with the **Code for Research** and the **Statement on Ethical Conduct**, where relevant, and any breaches are handled appropriately. The level of compliance will be evaluated each time the policy is reviewed and, if unsatisfactory, changes to the policy made.
